Introduction

Faculty of Law Universitas Indonesia (FHUI) has opened the International Undergraduate Program (*Kelas Khusus Internasional – KKI*) since 2010, based on the Rector Decree of Universitas Indonesia No. 0424/SK/R/UI/2010 concerning the Permission for the Implementation of the International Undergraduate Program at FHUI. This program consists of 119 lectures, and the courses are taught primarily in English. Lectures on practical legal skills and proceedings are taught in mixed language/Bahasa Indonesia.

Specializations

The International Undergraduate Program (KKI) at FHUI offers six areas of specialization:

1. Economic Law
2. Public International Law
3. Private International Law
4. Islamic Law
5. Environmental Law; and
6. Constitutional Law

International Exposure

International Undergraduate Program student is obliged to participate in various international exposure programs, namely student exchange, study abroad and/or summer/winter course in the minimum of 1 (one) semester overseas. To participate in such program, student can be nominated to the universities or faculties partner all over the world. FHUI has international cooperation agreements with Faculty of Law all over the world which offers a wide range of courses for students. FHUI has been admitting international students as exchange students as well – National University of Singapore, Sciences Po Paris, Australian National University, University of Groningen, St Petersburg University and many more.

Education Fees During International Exposure

When conducting the student exchange schemes, KKI student is required to pay education operational fees at UI as well as the travel and living expenses abroad. There would also be limited quota relating to students who are be able to join this scheme which depends on the Faculty's MoU with the partner university. Whilst in conducting the study aboard scheme, KKI student would only be required to pay for the education operational fees at UI with the total amount IDR2.000.000,- (two million Indonesian Rupiah). KKI students also have to cover the tuition fees at the designated university, travel fees as well as living expenses while studying abroad.

Student Admission

There are two registration procedures namely:

1. Talent Scouting invitation from Universitas Indonesia; or
2. Admission test through the SIMAK UI for international program.

Requirement

1. The prospective student must have graduated from high school or equivalent to the diploma age within a maximum period of five years. As an additional document of diploma, General Certificate of Education (A level) is also acceptable, the advanced International Certificate of Education at a "Pass" level, the Diploma Program of the European Baccalaureate, and the Diploma Program of International Baccalaureate.
2. Prospective students also have to prove their English proficiency in the form of an ETS certified TOEFL certificate with a minimum score of 580 (PBT) or 79 (IBT) or an IELTS certificate with minimum score of 6.5.
3. For prospective students with foreign citizenship ITP/PBT TOEFL min. 580 or iBT TOEFL min. 79 or IELTS min. 6.5 or Cambridge FCE and CAE min. 176.
4. International student that are admitted to the program are required to:
 - Acquire BIPA (Bahasa Indonesia untuk Penutur Asing) 3, or
 - Acquire TIBA (Test Bahas Indonesia Sebagai Bahasa Asing) Level 3

Tuition and Admission Fees

Indonesian Citizens

- Admission Fee: IDR 25,000,000 (twenty-five million rupiah)
- Education Operation Fee: IDR 28,000,000 (twenty-eight million rupiah)

Foreign Citizens

- Admission Fee: IDR 32,000,000 (thirty-two million rupiah)
- Education Operation Fee: IDR 28,000,000 (twenty-eight million rupiah)
